## **Eight Families Win \$1,000 KESPT College Savings Accounts**

*Eight Kentucky libraries also win \$500 for Summer Reading Programs*

FRANKFORT, Ky.—Eight Kentucky families have been randomly selected as winners in the “Destination College Savings” 2011 Summer Reading Program, sponsored by the Kentucky Education Savings Plan Trust (KESPT) and the Kentucky Department for Libraries and Archives (KDLA). A \$1,000 KESPT college savings account will be set up in the name of the winning family’s child.

“Destination College Savings” was a component of this year’s Summer Reading Program, held at public libraries throughout Kentucky. Each library where the winning students participated also will win \$500 for future summer reading programs.

“The libraries were an excellent partner in helping us bring the ‘Destination College Savings’ to thousands of Kentucky students,” said David Lawhorn, KESPT administrator. “This program not only encouraged children to read over the summer, but it also prompted family discussions about how to save early for higher education.”

More than 7,500 families around Kentucky submitted entries in the Destination College Savings program. The winning children and libraries are listed below.
